Volunteer mentors provide tutoring and a supportive, caring relationship with at-risk students. Significant changes in attitude and behavior are seen in these children as the mentors provide the emotional, social and academic support the students need to succeed. Using 19 years of experience and comprehensive matching measures, Affinity Mentoring facilitated 286 mentor-student relationships in four schools during the year ended June 30, 2020, for 6,129 volunteer hours. In the past year, Affinity Mentoring received in-kind gifts of office space valued at \$43,000. This amount is excluded from revenue per IRS instructions.
